Farmer's Market Nutrition Program

The goal is to help increase fruit and vegetable consumption and promote healthy and happy families. Women, Infants, and Children (WIC) has already distributed 23 voucher books to several WIC families in 2021.

Q: What's new and different then last year?

A: Previously WIC issued \$30 worth of vouchers per family. This year WIC has increased the amount received by each family to \$30 per eligible person in each family.

Q: Who is eligible?

A: If you are pregnant and receiving WIC benefits, or have children under the age of five who are receiving WIC benefits you are eligible. If you are pregnant and/or have children under the age of five, please contact the Florence County Health Department to check your eligibility status to enroll in WIC. The Florence County Health Department currently provides 36 families and 66 WIC participants with nutrition benefits.

Q: What stands accept the vouchers?

A: Lila Tibb's Farmer's Market, Located near Florence Town Hall, is open Wednesday's 9AM-4PM and in Armstrong Creek on the corner of Hwy 8 & 101 on Saturday's 10AM-2PM.

A: Tink's Farmer's Market, located on Main Street in Niagara.



Q: How long does the WIC Farmer's Market program last?

A: Farmer's Market vouchers will be accepted through October 2021.

A: In addition to the Farmer's Market coupons, WIC has also increased it's fruit and vegetable benefits on the WIC card to \$35 per month through September.

What is a Tourist Rooming House?

A Tourist Rooming House, also known as a TRH, is a home or cabin rented for a short period of time (e.g. Air B&B or VRBO). In 2021, 24 TRH's were inspected by Florence County's newest Registered Sanitarian, Amber Kolberg and summer intern, Savannah Vassar. CONGRATULATIONS on your accomplishment Amber!
